In this regard, SEBI in supersession of above said circulars has further issued Circular SEBI/HO/MIRSD/MIRSD-PoD-1/P/CIR/2023/37 dated March 16, 2023 (available on the website of our RTA www.beetalfinancial.com and Company's website www.jaipurhospital.co.in regarding mandatory furnishing of PAN, KYC details and Nomination by holders of physical securities, and as per which, the folios, wherein any one of the cited document/details are not available on or after 1st October, 2023, shall be frozen by the RTA, and the security holder(s) whose folio(s) have been frozen shall be eligible to lodge grievance or avail any service request from the RTA only after furnishing the complete documents / details as mentioned above. Frozen folios shall be referred by the RTA / listed company to the administering authority under the Benami Transactions (Prohibitions) Act, 1988 and/or Prevention of Money Laundering Act, 2002, if they continue to remain frozen as on 31st December, 2025.
